HEDIS/NCQA/Risk Adjustment Updates for Providers

Important Information About Medical Record Requests

The Affordable Care Act's Commercial Risk Adjustment ("RA") program equalizes risk for individual and small group plans inside and outside the Marketplace. Health Options complies with this program and its requirement to verify that Members with specific chronic illnesses have an annual provider visit during which their illness is documented. We frequently need to request copies of Members' medical records for that purpose.

You can reduce the number of RA-related record requests you receive by including appropriate ICD-10 coding on claims. Additional information about Risk Adjustment, including tips to improve clinical documentation, is available here. Be aware that this will not affect the quantity of requests for records Health Options needs for HEDIS (Healthcare Effectiveness Data and Information Set), which is a separate program with different information requirements.

Credentialing Reminders

When new physicians join a practice location, we recommend beginning the credentialing process as soon as possible to avoid delays. This will minimize disruptions to the practice and Members' claims. You can help the process run smoothly by doing the following:

- Include a current copy of the provider's Certificate of Insurance with the Provider Add/Change form and send both to Dataintegrity@healthoptions.org.
- Ensure that the new Provider's CAQH number is included, and that their information and attestation in the CAQH system are current upon submission of the credentialing request.

Itemized Bill Submission Reminder

Institutional inpatient and outpatient claims of \$20,000 or more must include an itemized bill to be considered for payment. You can avoid processing delays by emailing the itemized bill to itemizedbill@healthoptions.org on the same day the associated claim is submitted.
