

Preferred Site of Care Incentive Program

Infusion Therapy



As a nonprofit health insurance company, Community Health Options is committed to finding ways to lower costs for our Members. As part of our efforts, we offer a voluntary **Site of Care (SOC) Incentive Program** that allows Members receiving infusions for a designated set of medications to switch to a preferred provider. We partner with preferred infusion providers to provide high-quality care at a **fraction of the cost** of non-preferred providers. These preferred providers may include lower-cost facilities, provider offices, infusion centers, and home infusion settings.

In addition to these savings, Members will be offered a monetary incentive payment when receiving infusions from a preferred Site of Care provider. Members are eligible for up to \$1,000 annually in incentive payments, and each incentive payment is made after a claim is processed.

The amount of the incentive will be based on the servicing provider's reimbursement rate. A 2-Tier structure is in place:

2-TIER STRUCTURE

	Tier-1 Providers	Tier-2 Providers
Initial Switch	\$250	\$150
Subsequent Infusions	\$50	\$25

The incentive is issued according to the dollar amounts in the table above and coordinated with the specific Tier-1 and Tier-2 providers.

These **preferred providers** may include lower-cost facilities, provider offices, infusion centers, and home infusion settings.

Preferred Site of Care Incentive Program Details:

- Members must have **active eligibility** on the date a claim is paid to the provider to receive an incentive payment.
- Members already using a preferred provider will **automatically** receive the incentive payment.
- Incentive payments are processed **8-10 weeks** after a claim is paid.
- The maximum cumulative payment for each drug is **\$1,000 per calendar year**. Members who switch from a non-preferred SOC servicing provider to a preferred SOC servicing provider will be eligible for the higher incentive once for each specified drug.
- If a **Tier-2 provider** moves to a Tier-1 provider, the Member will be eligible for the higher incentive payment.
- If a **Tier-1 provider** moves to a Tier-2 provider, the Member will continue to receive the higher payment for **three additional months** before reverting to the lower payment.
- The program is focused on those service codes (specifically J-Codes and Q-Codes) with the **largest savings opportunity**.*
- Members will receive a 1099-MISC document from Community Health Options by January 31 for tax purposes if they receive **\$600 or more** in incentives during a calendar year.
